

Clean Fairfax Reusable Party Kit Terms & Conditions

1. All Party Kit equipment is owned by and remains the property of **Clean Fairfax Council, Inc.** ("Owner").
2. A refundable deposit is required before your booking can be confirmed. Please note that the deposit amount does not reflect the whole replacement cost of everything contained in the kit. The deposit is charged in order to ensure that the Borrower understands there is a value to the kit, and to allow the Owner to recoup at least some of the value should anything go awry. The deposit does not reflect your entire financial responsibility for the kit.
3. You may cancel the booking at any time prior to the start date of your rental, but please be considerate of others and if you have a change of plans, let us know as soon as possible.
4. In the unlikely event that the Owner is unable to fulfil your booking due to circumstances beyond their control the Owner's liability is limited to the refund of all monies paid.
5. You are responsible for the Party Kit equipment for the duration of the rental period and adequate care should be taken to ensure that everything is returned in the same condition that it came in.
6. The Owner accepts no responsibility for injury which occurs during the use of the Party Kit equipment.
7. All Party Kit equipment is washed in a domestic kitchen / dishwasher where allergens may be present. If you have any concerns about allergen contaminants please wash equipment prior to use.
8. The Party Kit should be returned within 1 week of the rental date, complete, intact, clean, and dry.
9. If the kit is returned dirty, a penalty of \$20 will be withheld from your deposit.
10. You will be eligible for a full refund of the paid deposit (less the nonrefundable transaction fees if paid via Venmo or Zelle) when the Party Kit has been returned on time, clean, complete and undamaged.
11. You are responsible for any breakages, non-repairable damage or loss of Party Kit equipment. Replacements will be charged at the purchase price of the new equipment item(s) - see below for item amounts.
12. In the event that the replacement cost of missing/damaged items exceeds the deposit amount, the full deposit amount will be retained by the Owner and you will be invoiced for the difference. Payment of the remaining balance will be due upon your receipt of the invoice.
13. The quantity and condition of the Party Kit equipment, in the absence of definite proof to the contrary, is as seen by the Owner upon receipt of the returned Party Kit.

14. Your contact details will be stored on an electronic storage and retrieval system which has been created for the exclusive use of the Owner for keeping in contact with you about your booking. This data will not be used by any third party without prior consent.

Acknowledgment of terms and conditions:

I understand that while Clean Fairfax (CF) requires that all dishware be run through a dishwasher before being returned, CF makes no representations or guarantees as to the cleanliness of the dishware. Clean Fairfax recommends that all dishware be washed and sanitized before use. Clean Fairfax is not liable for any damages or injuries that may arise from the use of the dishware, and I agree to indemnify, defend and hold harmless Clean Fairfax, its officials, agents and employees from and against any and all claims, damages, losses and expenses, including legal fees arising out of or in any way associated with the use of the dishware made available by CF. In addition, I also agree to do my best to minimize loss, by announcing and posting included signage to inform all guests the items are reusable.
